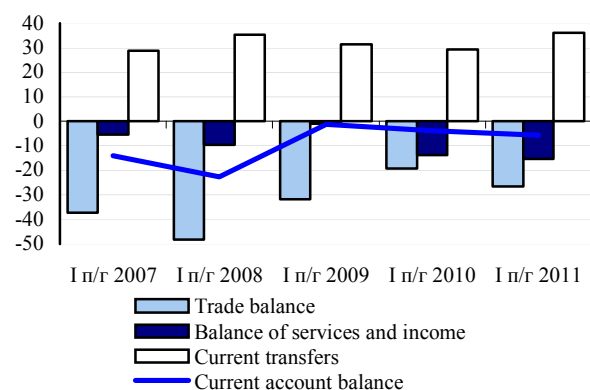
## CURRENT ACCOUNT

According to the results of the first half of 2011, the balance of payments was formed positive in the amount of US\$ 91.3 million.

The deficit<sup>1</sup> of **current account** constituted 8.9 percent to GDP or US\$ 128.4 million.

**Chart 1: Current account**

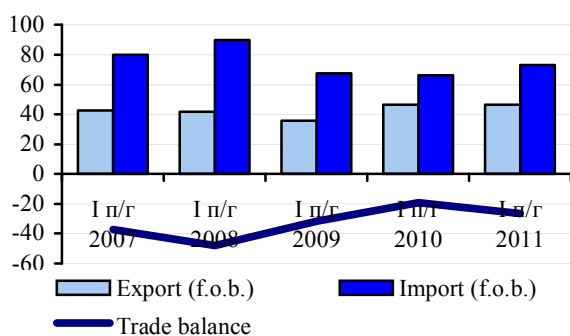
*in percent to GDP*

TRADE BALANCE<sup>2</sup>

The deficit of the **trade balance** in the Kyrgyz Republic based on the results of the first half of 2011 increased by 62.0 percent against the first half of 2010 and constituted US\$ 586.4 million in FOB prices (with regard of NSC and NBKR estimates). Increase in the volume of a negative trade balance is connected with more rapid growth of import as compared to export.

In the reporting period **the external turnover** in FOB prices increased by 25.7 percent in comparison with the first half of 2010 and constituted US\$ 2 652.4 million.

Export of goods in FOB prices (with regard of NSC and NBKR estimates) increased by 18.2 percent in comparison with the first half of 2010 and constituted US\$ 1033.0 million. The major increase of export was due to the expansion of delivery of gold, which increased by 39.6 percent or constituted US\$ 142.9 million in absolute expression. In the reporting period, the export, without notice of gold, increased by 3.2 percent and constituted US\$ 528.8 million. Re-export of petroleum products to CIS countries increased by 57.3 percent or constituted US\$ 6.8 million compared to the first half of 2010.

According to the functional structure of the export, in the reporting period, a growth was noted on all articles of the functional distribution, except for raw materials. The largest export category was accounted for interim goods (63.0 percent from the aggregate export), and consumer goods (22.4 percent). A share of raw materials decreased by 17.1 percentage points and constituted 3.4 percent from the cumulative export.

The growth of the volume of export of *interim goods* achieved 46.1 percent or US\$ 184.1 million in absolute expression. The export volume of interim goods achieved the amount of US\$ 583.3 million, out of which US\$ 504.2 million were provided by the supply of gold, mainly to Switzerland (72.6 percent from the total export of gold) and UAE (27.2 percent). Growth in the export volume of gold was due to the increase of the prices by 25.5 percent and the physical volume of supplies increased by 11.2 percent.

The export volume of *consumer goods* increased by 36.0 percent (by US\$ 55.0 million), and constituted US\$ 207.5 million. This growth was mainly due to the increase in the supply of vegetables in 2.0 times as compared to the same period of the previous year and constituted the amount of US\$ 51.1 million. Besides, a tendency of increase in the export of clothes and clothes accessories, milk and dairy products (increase by 16.6 and 26.3 percent respectively) persisted. The export of vegetables mainly increased to Kazakhstan for the amount of US\$ 18.7 million, whereas supplies to the Russian Federation decreased by 7.8 percent and constituted US\$ 9.3 million. Supply of bean products to Turkey increased in 2.0 times. Clothes and clothes accessories were exported to Russia (99.0 percent of all supplies), in the amount of US\$ 74.0 million, which is by 14.8 percent higher as compared to the first half of 2010.

Export of *energy products* achieved the amount of US\$ 77.9 million, which is by US\$ 33.8 million higher as compared to the first half of 2010. This growth was mainly due to the increase of export of electric energy supplies to Kazakhstan, the volume of which increased in 6.5 times and achieved US\$ 26.1 million. The value of re-export of aviation kerosene increased by 9.6 percent and constituted US\$ 27.3 million. This increase was mainly as a result of advance in prices by 24.6 percent, whereas the physical volume decreased by 12.1 percent. Increase in the supply of aviation kerosene was significant to Russia (in 1.8 times). Along with this, there was also decrease in the export of aviation kerosene by 4.00 percent to UAE and by 18.7 percent to Turkey in the reporting period. The export weighting of energy products to CIS countries and non-CIS countries, constituted 60.2 and 39.8 percent respectively.

The cumulative volume of export of **raw materials** achieved the amount of US\$ 31.4 million as a result of decrease in the supply by 80.0 percent (or by US\$ 125.9 million). This negative tendency is mainly based on the decrease in the physical volume of supplies of inorganic chemicals, the export of which decreased by US\$ 8.4 million in the first half of 2011. The export of this commodity constituted US\$ 137.7 million or 87.5 percent from the overall export of raw materials as compared to the same period of the previous year. Decrease in the export of tobacco to Russia by 46.8

percent or US\$ 3.5 million also affected the export of raw materials.

Export of *investment goods* in the reporting period increased by 73.9 percent and constituted US\$ 26.4 million. According to the goods structure of this category, the growth of re-export of automobiles, not covered by other categories (by US\$ 6.4 million) and aircraft planes and corresponding equipment (by US\$ 6.4 million) was observed. In the reporting period, decrease in the export of investment goods according to the position of electric and linear telephone and telegraph devices by US\$ 4.0 million was observed. The export of investment goods to CIS and non-CIS countries constituted 73.6 and 26.4 percent respectively.

**Import** of goods in FOB prices increased by 31.0 percent and constituted US\$ 1619.4 million.

In the functional structure of import, consumer goods (38.7 percent from the overall volume of import), interim goods (22.7 percent)<sup>3</sup> and energy products (21.7 percent) prevailed as before.

The import of *consumer goods* increased by 51.4 percent and constituted US\$ 678.1 million. The growth of medicaments is observed (by 54.4 percent), mainly due to humanitarian aid from USA in the amount of US\$ 13.9 million. Supplies of wheat and mangcorn flour increased by US\$ 19.1 million, sugar, molasses and honey by US\$ 15.5 million, coffee, tea, cocoa and herbs by US\$ 10.0 million, ethereal oil and perfume by US\$ 9.3 million, meat and meat products by US\$ 6.7 million. The decrease in the import of fruits and nuts (by 16.7 percent) and rice (by 15.3 percent) was noted. The export of meat and meat products from China increased by 25.7 percent (24.3 percent from the overall import of meat), and clothes and clothes accessories more than in two times. A

negative tendency was observed on the import of rice from China (decrease by 57.3 percent as compared to the first half of 2010) and fruits and nuts (by 43.2 percent). There was an increase in the import of the previously used light vehicles from Japan (in 1.9 times). The import of chocolate and other products containing cocoa from CIS countries, in particular, from Russia increased by 64.4 percent, including the cereal, flour and starch products by 62.0 percent and medicaments by 24.7 percent. The import of wheat and mangcorn flour from Kazakhstan increased by US\$ 12.3 million, cigarettes containing tobacco increased to US\$ 4.0 million.

The import of *interim goods* according to the results of the reporting period increased by 33.5 percent and constituted US\$ 397.4 million. According to the functional structure of this category, within the reporting period there was an increase in the supply of crude iron and steel by 28.0 percent (13.6 percent from the overall volume of interim goods), including plastic material in its original form by 76.6 percent, textile fabric by 69.6 percent, fertilizer by 43.6 percent, parts and accessories of the motor vehicle by 46.0 percent. At the same time, decrease in the import of aluminum by 22.3 percent was noted.

The increase in the import of rubber tires by 17.3 percent from Russia observed. Also there was an increase in the supply of fabric from China (by 71.3 percent or by US\$ 10.9 million). The import of crude iron and steel from Russia increased by 36.7 percent or by US\$ 6.8 million; from China it increased by US\$ 1.6 million.

The import of *energy products* within the reporting period increased by 3.8 percent, and constituted US\$ 380.5 million. The share of petroleum products in this group of goods achieved 86.0 percent, and traditionally, the major supplier of petroleum products was Russia (84.9 percent from the overall volume of supplies of this product). In the reporting period, the increase in the value of the following imported petroleum products was observed: motor spirit by 27.9 percent (at the expense of the increase of the physical volume by 17.0 percent), gas oil - by 50.2 percent (at the expense of the increase of the physical volume by 7.4 percent), fuel oil - by 60.7 percent (at the expense of the increase of the physical volume by 17.7 percent). The

import of aviation kerosene is decreased by 59.3 percent, which is mainly based on the reduction of its natural volume by 71.3 percent under the price advance by 41.6 percent. Supplies of crude oil in the first half of 2011 were completely terminated. The import of coal decreased slightly by 5.3 percent or by US\$ 0.9 million. The import of natural gas at the expense of the price advance by 13.2 percent increased by 10.6 percent, whereas the physical volume decreased by 2.3 percent.

The import of *investment goods* in the reporting period increased by 38.4 percent and constituted US\$ 235.7 million. According to the structure of this category, import of motor vehicles for the transport of goods is significantly increased (by 61.7 percent). Besides, the increase in supplies of mechanical shovels, excavators and shovel-loaders (in 4.3 times) was observed including the electric and linear telephone devices (in 2.4 times). In the first half of 2011, the biggest transaction in this group of goods was the import of the telecommunications devices and equipment from China for the total amount of US\$ 40.3 million and the import of motor vehicles for the transport of goods and special-purpose motor vehicles from USA for the total amount of US\$ 27.0 million. Moreover, vehicles for earth handling, sub-grading, earth excavation and drilling were imported from USA for the total amount of US\$ 6.4 million.

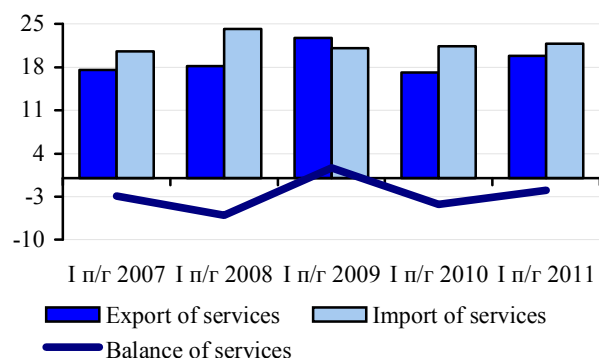
The import of *raw materials* constituted US\$ 61.3 million which is higher by 13.3 percent as compared to the corresponding period of the previous year. Mainly the import of other inorganic chemicals decreased by 38.1 percent or to US\$ 9.5 million. The supplies of inorganic chemicals decreased mainly from Kazakhstan by 51.9 percent. At the same time, increase in the import of unmilled cereals and mangcorn from Kazakhstan by 52.7 percent or by US\$ 11.8 million was observed within the reporting period. Almost the overall volume of the imported raw materials was provided by CIS countries (90.2 percent).

## **BALANCE OF INTERNATIONAL SERVICES**

**Turnover of international services** as per the results of the first half of 2011 increased by 27.8 percent and constituted US\$ 923.3 million.

In the first half of 2011, the negative balance of the **international services** achieved the amount of US\$ 44.5 million, whereas the negative balance achieved US\$ 79.6 million in the same period of 2010. The increase in the export of services by 36.7 percent as compared to the increase of the import of services by 20.7 percent produced the highest effect on the formation of this indicator.

According to the results of the first half of 2011, **the export of services** amounted US\$ 439.4 million. The growth in this indicator is based on the increase in the export of services almost on all items of international services as "Engineering services" (in 3.7 times), "Travels" (by 53.0 percent), "Business services" (by 39.6 percent) and "Transport services" (by 19.2 percent). The aggregate growth on the items as "Communication services", "Financial services", "Computer and information services", "Government services" and "Business services" achieved 37.0 percent within the reporting period as compared to the same period of 2010.

Within the reporting period, the export on the item "Transport services" achieved the amount of US\$ 78.9 million, which constituted 18.4 percent from the overall volume of export of services. The increase in the same indicator was based on the growth of the export of services rendered via airline service and automobile transport by 9.8 and US\$ 4.4 million respectively.

The volume of the export of services on the item "Travels" increased by US\$ 203.8 million and constituted 46.4 percent from the overall volume of

the export of services. At the same time the increase of services rendered both on the items of "Business travels" and "Personal travels" was noted.

The export of services on the item "Engineering services" achieved the amount of US\$ 20.8 million, having increased by US\$ 15.3 million as compared to the same period of the previous year.

It is noteworthy that in the first half of the year 2011, the decrease in the export of "Insurance services" and "Other services" by US\$ 7.7 million is noted and their total share in the cumulative export of services achieved 7.9 percent.

In the first half of 2011, **the import of services** increased by 20.7 percent and constituted the amount of US\$ 483.9 million. This increase is explained by the growth of such significant items of services as "Other services" (by 69.5 percent), "Travels" (by 35.3 percent), "Transport services" (by 19.2 percent), and "Business services" (by 14.6 percent). As for the rest items of the import of services, the decrease was observed within the reporting period. Thus, the cumulative decrease on the items "Engineering services", "Financial services", "Computer and information services" and "Government services" constituted US\$ 4.1 million.

The import of transport services in the amount of US\$ 210.2 million increased by 19.2 percent as compared to corresponding index of 2010. This growth was provided by the increase in the import of services rendered via airline service and automobile transport by 72.9 and 44.8 percent respectively.

The volume of the import of services on the item "Travels" increased by US\$ 161.9 million and constituted 35.3 percent of the total volume of the import of services.

According to the item of "Business services" and "Other services" the increase achieved 8.0 and US\$ 7.3 million respectively. Their aggregate specific weight constituted 16.6 percent from the total volume of the import of services.

## INCOME

According to the results of the first half of 2011, the negative balance of the incomes constituted US\$ 298.3

million, which is by 66.6 percent higher as compared to the same indicator of the first half of 2010.

The negative balance growth of this item is associated with the incomes increase from direct investments based on the investment activity in Kyrgyzstan. Thus, incomes on direct investments of foreign investors increased by 82.7 percent and constituted US\$ 270.3 million which is caused by the increase of reinvested incomes in 2.3 times, the overall volume of which achieved US\$ 264.1 million.

Within the reporting period, the negative balance of incomes on other investments decreased from US\$ 16.9 million in the first half of 2010 up to US\$ 12.8 million.

The negative balance of the item "Compensation for employees" achieved US\$ 15.2 million, having increased by 6.1 percent as compared to the similar indicator of the first half of 2010.

### TRANSFERS

As per the results of the first half of 2011, the balance of **current transfers** increased by 46.2 percent as compared to the indicator of the corresponding period of 2010 and had positive balance in the amount of US\$ 800.9 million.

In the first half of 2011, the net flow of current transfers to the general government sector (standard presentation of the balance of payments) constituted US\$ 49.5 million, which is by 70.8 percent higher of the index for the corresponding period of 2010. This growth was mainly explained by the increase in the volume of money grants received by the government sector.

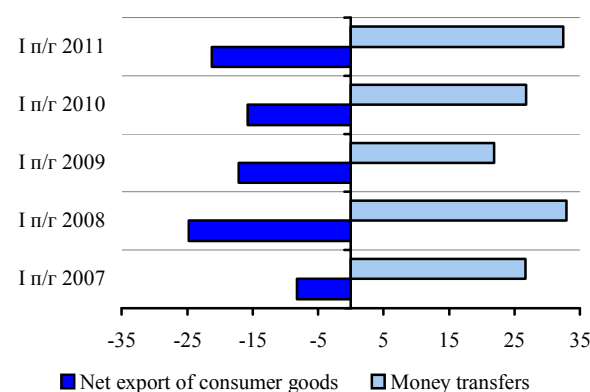
Net flow of current transfers to the **other sectors** (standard presentation of the balance of payment) constituted US\$ 751.4 million, having increased by 44.8 percent. The major part of the general volume of incomes was from "Transfers of migrants" item. In the reporting period, the net flow from this item increased by 43.4 percent (or by US\$ 217.3 million).

The biggest share was associated with a gross flow of transfers of migrants on the system of money

transfers<sup>4</sup> (91.1 percent). Within the reporting period, the net flow of money transfers increased from US\$ 453.0 million to US\$ 650.6 million as compared to the corresponding indicator of the first half of 2010. At the same time the geographical structure of money transfers, in general, remains unchanged. According to the results of the first half of 2011, the major volume of money transfers was from the Russian Federation (93.4 percent), USA (2.4 percent) and Kazakhstan (2.3 percent). Outflow of money transfers is mainly noted to the Russian Federation (97.1 percent).

The net balance of money transfers covers the net export of consumer goods, as before, which in turn came up with the deficit in the amount of US\$ 470.6 million.

### CAPITAL AND FINANCIAL ACCOUNT

According to the results of the first half of 2011, the **capital and financial account** had a positive balance in the amount of US\$ 169.6 million, which is by 28.9 percent higher than the corresponding rate of the first half of 2010.

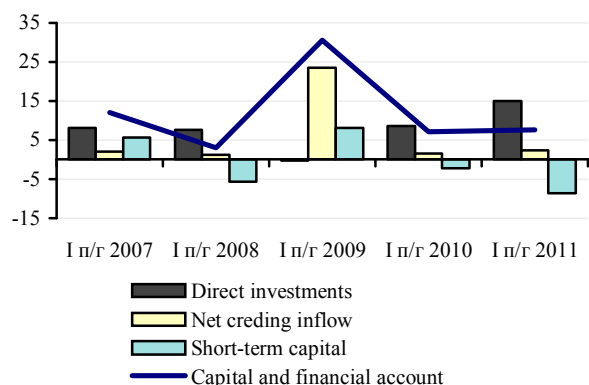
The deficit of the **capital account** increased from US\$ 15.2 million to US\$ 25.1 million.

This change took place due to the effects of the transactions connected with capital transfers of migrants who moved abroad for permanent residence.

Net position on the item "Transfers of migrants" increased from US\$ 35.8 million to US\$ 50.5 million within the reporting period.

Positive balance of **financial account** increased by 32.7 percent and achieved US\$ 194.8 million.

This change was due to the inflow of the capital on direct and other foreign investments. According to the results of the first half of 2011, the inflow of direct investments to the Kyrgyz Republic constituted US\$ 329.8 million, having increased in 2.1 times as compared to the corresponding rate of the same period of 2010. The main inflow in the structure of direct investments was associated with the reinvested incomes, the volume of which increased from US\$ 115.6 million to US\$ 264.1 million.

The increase of the net flow of direct foreign investments was at the expense of the investments from such countries as Canada with the overall amount of US\$ 234.3 million, China- US\$ 36.8 million, Great Britain - US\$ 21.5 million and Kazakhstan - US\$ 11.1 million.

According to the types of economic activities, the inflow of direct investments was mainly observed to the manufacturing industry for the amount of US\$ 228.9 million, capital asset for the amount of US\$ 43.1 million, financial activity in the amount of US\$ 29.1 million and to the area of trade in the amount of US\$ 27.3 million.

Within the reporting period, the item "Portfolio Investments" had the negative balance in the amount

of US\$ 144.6 million, whereas the corresponding indicator of the first half of 2010 was positive in the amount of US\$ 7.0 million.

According to the results of the first half of 2011, the item "Other Investments" came up with the net surplus in the amount of US\$ 9.5 million against the deficit in the amount of US\$ 20.2 million, in the corresponding period of 2010. This item was formed under the impact of more significant increase of liabilities of the residents against the increase of their external assets.

Increase in the external assets of the residents up to US\$ 43.9 million is based on the growth of cash money and deposits of commercial banks of the country in foreign banks and constituted US\$ 14.2 million, and also on the increase of accounts of entities in foreign banks which achieved US\$ 32.6 million. Within the reporting period, the decrease of debt receivables by US\$ 2.8 million was also observed.

External liabilities of the country were formed under the impact of the increase in the volume of net inflow of loans by 83.1 percent.

The major volume of the net inflow of loans in the first half of 2011 is associated with the private sector and constituted US\$ 40.3 million, which is in 3.5 times higher of the corresponding indicator of the first half of 2010. The volume of inflow of loans to the government sector decreased by 23.4 percent and constituted US\$ 13.7 million.

It is noteworthy that within the reporting period, fulfillment of financial liabilities of the Kyrgyz Republic on maintaining state external debt was produced in full scope and on timely basis.

According to the results of the first half of 2011, the credit indebtedness of the enterprises before the non-residents increased by US\$ 1.1 million, against the negative meaning in the amount of US\$ 25.1 million in the first half of 2010.

The item "**Errors and Omissions**" has a positive balance in the amount of US\$ 50.0 million, which testifies the insufficient accounting of export operations and of the capital inflow to the republic.

In the analyzed period, **gross international reserves** constituted US\$ 1 911.4 million, which is by 21.9 percent higher of the corresponding indicator

of the first half of 2010. The coverage ratio with gold and foreign exchange reserves of the future import of goods and services constituted 4.3 months.

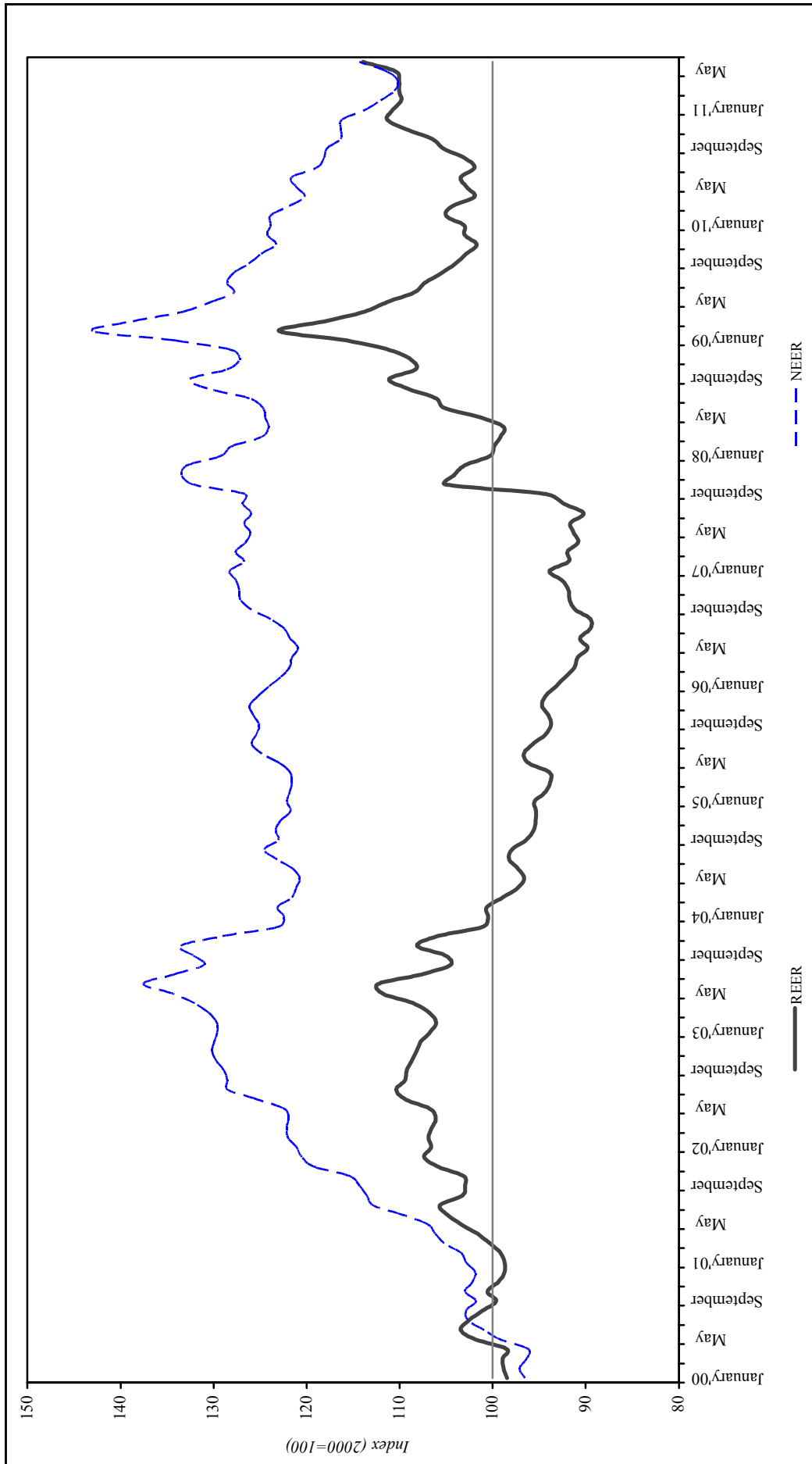
