Balance of Payments of the Kyrgyz Republic

"Balance of payments of the Kyrgyz Republic" is issued by the National Bank of the Kyrgyz Republic. The legislative basis for the balance of payments are the Law of the Kyrgyz Republic as of July 29, 1997 No. 59 "On the National Bank of the Kyrgyz Republic" and the Resolution of the Government of the Kyrgyz Republic as of November 3, 2000 No. 645 "On measures to improve statistics of the balance of payments of the Kyrgyz Republic". This document reflects last tendencies in external sector development and shows statistical data on the balance of payments, external trade, international reserves, external debt and international investment position, as well as construction methods of balance of payments and informational database. This document is published 4 times a year in January, May, July and October and has 3 language versions: Kyrgyz, Russian and English.

Last day for update of data for the present publication is October 20, 2015.

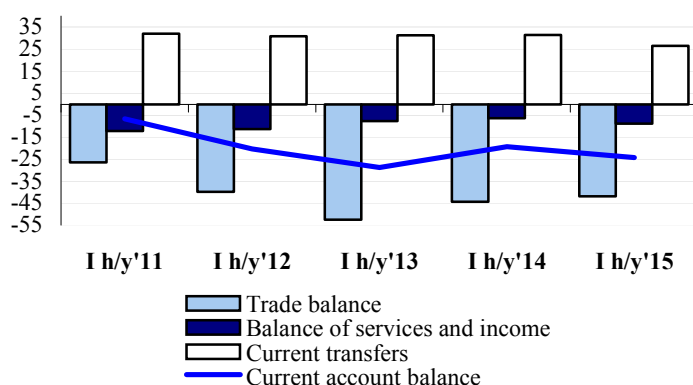

THE CURRENT STATE OF THE BALANCE OF PAYMENTS

Chart 1. Current account

in percents to GDP



In the first half of 2015, the deficit of the account of current account transactions was formed on the background of reduction of the negative balance of the trade balance and decrease in the volumes of money transfers. As a result, deficit of the current account transactions constituted 24.2 percent of GDP¹.

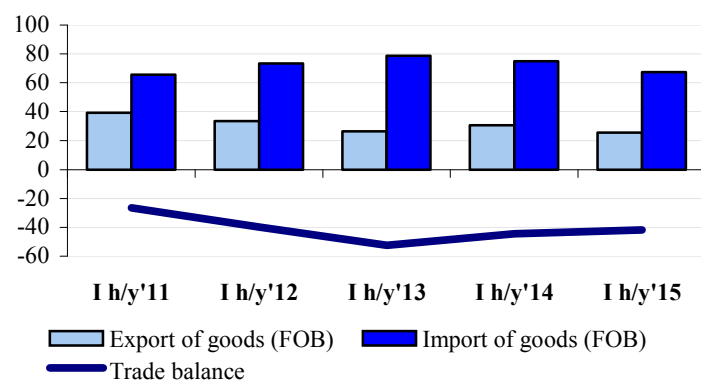
According to the National Bank estimates, deficit of the current account position with regard to the NBKR additional estimates² amounted to USD 247.9 millions (16.0 percent to GDP).

TRADE BALANCE

Decrease in negative balance of the trade balance according to the results of the first half of 2015, conditioned by a rapid decrease in imports against exports.

Trade balance in the Kyrgyz Republic for the first half of 2015 was found with negative balance in the amount of USD 1001.7 millions having decreased by 25.2 percent against similar indicator of the corresponding period of 2014.

External trade turnover in FOB prices decreased against the first half of 2014 by 12.8 percent and constituted USD 2 694.0 millions.

Exports of goods in FOB prices without regard for additional estimates of the National Statistics Committee and the National Bank of the Kyrgyz Republic

constituted USD 712.7 millions having decreased by 2.7 percent as compared to the indicator of the first half of 2014. Despite the positive dynamics of the export of gold, decrease in the volumes of export of consumer goods and raw materials affected the decrease in the total volume of export. **Export excluding gold**³ in January-June of 2015 constituted USD 301.2 millions having decreased by 32.0 percent as compared to the corresponding indicator of the first half of 2014. In the structure of the export, the main volume of decrease was in vegetables, articles of apparel and clothing accessories and aviation fuel exported as board stocks.

Exports excluding gold and re-exports⁴ decreased by 30.5 percent and constituted USD 245.7 millions.

In the reporting period, the export structure according to the SITC items changed due to dynamics of the exports of major commodity items. Significant increase in the supply of gold was due to increase in the specific weight of "goods and transactions not included in other categories of SITC" to 57.7 percent. Decrease in the specific weight of the group "industrial goods, not classified by type of materials" to 4.3 percent was due to the decrease in the volume of supplies of iron and steel, Portland cement, float glass, rubber tires and other goods. Decrease in the volume of consumer goods affected the decrease in the specific weight of groups "food products and live animals" and "different finished products" to 7.9 percent and 6.2 percent respectively.

Significant share in the export structure of the Kyrgyz Republic traditionally fell within the **manufacturing products** (metallurgical, textile and clothing industry) and **agriculture**.

In January-June 2015 in the production of **metallurgical production**, there was an increase in the volumes which was based by the growth of production and processing of precious metals⁵. Despite the decrease in prices for gold⁶ by 4.4 percent as compared to the indicator of the similar period of 2014, the impact of the price was compensated by the increase in the physical volumes of supplies by 48.8 percent. As a result, the value of export of gold increased by 42.2 percent. Supplies of iron and steel decreased by 93.1 percent as compared to the last year indicator.

There was a slight change in the supply of the rest metallurgical products.

In the reporting period as compared to January-June 2014 there was a decrease in the production of clothes and shoes, leather and other leather products⁷. With this regard, the export of clothes and clothing accessories in January-June 2015 decreased by 40.3 percent (to USD 20.2 millions). In the value, significant decrease is observed in the supplies of "articles of textile fabrics for women and girls" (by 40.8 percent or to USD 13.3 millions). Decrease in the value and physical volume was observed in all commodity items of this group, except for "knitted or crocheted women's and girls' articles".

It should be noted that there was a decrease in the average export prices in the goods of this group in the reporting period.

According to the results of January-June 2015, there was an increase in the volumes of gross output of **agricultural products** based on the increase in the production of livestock industry and start of the harvesting period of potato, vegetables, cereals and melons⁸. Despite this fact, there was a decrease in the supplies of the major agricultural products in the reporting period. The volumes of supplies of meat and meat products decreased by 55.4 percent, live animals by 24.5 percent. Decrease in the value of export crop production observed in the supply of vegetables by 45.9 percent, fruits and nuts by 18.5 percent.

Decrease in the supply of agricultural products, except for fruits and products from cereals, caused by a decrease in contract prices of exported goods. Along with this, the reporting period was marked by a slight increase in the supply of cotton due to the growth of export volumes.

In the first half of 2015 the specific weight of the registered **re-export**⁹ in the total volume of export decreased from 12.3 to 7.8 percent (by the amount of USD 55.5 millions). Decrease in the re-export was observed in the major products of this group. At the same time, the decrease in the supplies of "other inorganic chemicals" by 49.0 percent and "motor cars and other motor vehicles designed for the transport of people" by 81.6 percent and "motor vehicles for the transport of goods and special purpose vehicles" by 44.2 percent mostly affected on the total decrease of the re-export of goods. In the meantime, in January-June 2015 there was an increase in the re-export of railway vehicles and alternating current generators.

In the geographic structure of export, the share of Eurasian Economic Union countries decreased by 22.8 percent from 31.6 percent in January-June 2014. Decrease in the export to the Eurasian Economic Union countries is due to the reduction of the supplies of a number of consumer goods. Supplies to the non-CIS countries, on the contrary, increased in relative terms to 70.4 percent. The largest volume of exports go to Switzerland (46.3 percent). The increase in gold exports to Switzerland influenced the growth of the share of the country's total exports of gold from 62.3 percent to 79.9 percent.

In general, during the reporting period, the Kyrgyz Republic exported goods to 84 countries in the world (in January-June 2014 exports were made to 75 countries).

In addition to precious metals, such products as vegetables, fruits and nuts were exported abroad. The main trading partner was Turkey, whose share in the exports of goods reached 35.6 and 27.9 percent respectively.

The level of geographical concentration of the majority of the largest exported goods remains high.

In the reporting period, the most important category **in the commodity structure of imports** was a group of "mineral fuels, lubricants and related materials". Due to the significant reduction in the volume of imports of goods of other groups, the share of this group increased by 3.6 percentage points to 22.1 percent. The main share in this group is given to petroleum products.

During the reporting period there was a decrease of the value of import of petroleum products by 7.4 percent. This decrease was due to the decrease of average contractual prices by 26.6 percent, with an increase in the volume of import by 26.3 percent compared with the corresponding figures for January-June 2014. The largest decline was recorded on the value of imports of gasoline and diesel fuel, the import volumes in the aggregate decreased by USD 45.2 millions in absolute terms. At the same time, supplies of fuel oil increased (by 4.5 times or to USD 28.4 millions) due to the increase in the growth of physical volumes of import.

In addition to fuel and lubricants, significant share is given to natural gas and coal. Supplies of natural gas in the reporting quarter fell by 13.7 percent (to USD 4.0 millions), while coal supplies increased by 22.1 percent (USD 2.8 millions).

Rapid rates of reduction of supplies of used cars as a result of subsequent changes in the conditions of entry and customs clearance have reduced the specific weight of the group "Machinery and transport equipment" **in the commodity structure** of imports from 24.9 percent to 19.4 percent. In this group, the largest decline in imports was observed in "used cars" (a decrease by 95.6 percent or USD 128.2 millions). At the same time import volumes of such items as "linear electrical apparatus for telephony or telegraphy", "parts and accessories of motor vehicles" and other goods decreased. This decrease was partially compensated by an increase in the volume of imported cars for the transport of goods and special purpose vehicles; mechanical shovels, excavators and shovel loaders; moving, leveling, extracting or for earth machinery.

It should be noted that some products in this group, such as parts and accessories of motor vehicles; aircraft and related equipment; vehicles for the transport of goods and special purpose vehicles and others are partly imported for re-export.

The cost of manufactured goods classified by type of material, the share of which in the structure of imports accounted for 17.2 percent, decreased by 0.4 percentage points, to USD 335.3 millions. The largest item in this group is the item "iron and steel", imports of which in the reporting period decreased by 9.5 percent compared to the first half of 2014. The significant products of this group also include textile fabrics, rubber tires, various paper products and metals, as well as construction materials. There was a decrease in the value of almost all products of this group due to a decrease in import prices.

In the geographical distribution of the import, the share of imports of goods from Eurasian Economic Union countries constituted 49.6 percent, which is 5.7 percent more than in the first half of 2014. In general, during the reporting period, import to the Kyrgyz Republic is carried out from 129 countries of the world.

From Eurasian Economic Union countries there were mainly supplies of energy and food products. The main supplier of oil products was the Russian Federation, electricity and coal was supplied from Kazakhstan. Cereals and cereal products, sugar, vegetable oils and other food products are also supplied mainly from the Eurasian Economic Union countries.

Despite a significant decrease (by 59.5 percent) of the value, the main share in the structure of imports from foreign countries fell within a group of "motor cars". The share of non-CIS countries (mainly from Japan, Germany, China and Korea) is more than 58.5 percent of total imports of this commodity group. The structure of consumer goods imported from abroad observed growth of medical supplies from Germany, as well as the decrease in imports of meat and meat products from the United States.

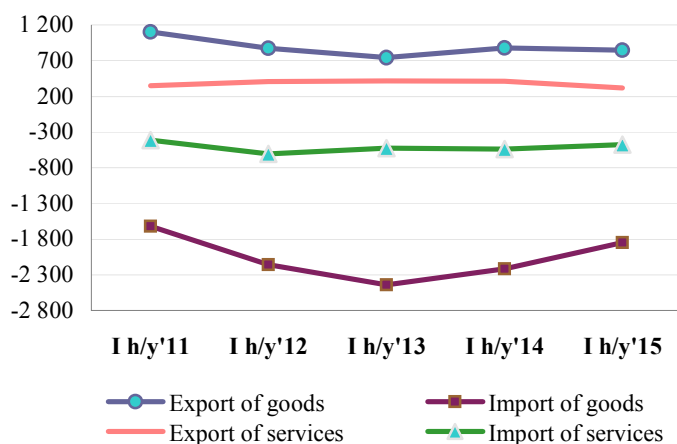

BALANCE OF INTERNATIONAL SERVICES

Along with a decrease in the foreign trade activity of the Kyrgyz Republic, the volume of international services decreased as well.

(In millions of USD)

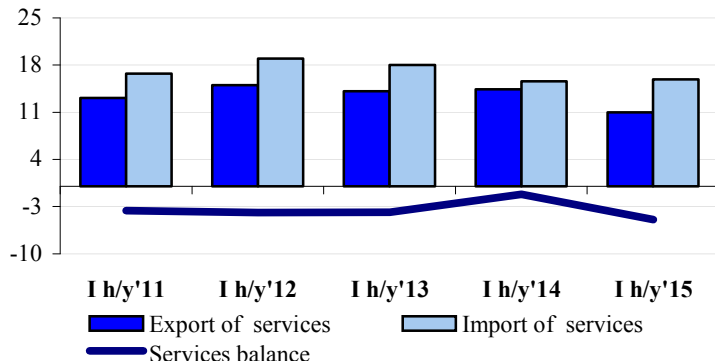

Import of services constituted USD 474.7 millions which constituted 25.7 percent of the import of goods.

of railway transport services by 14.0 percent, air transport services by 31.1 percent and motor car transport services by 32.8 percent, provided by residents of the country justified the reduction of the total volume of import of transport services by 19.3 percent.

The balance of the item "travels" was found with the surplus in the amount of USD 10.9 millions, which is by 10.2 percent lower of the compared indicator in the first half of 2014. Decrease in the provided services on the item "travels" is explained by the decrease in the private and business trips of non-residents.

Net export of "business services" within the reporting period was found positive and constituted USD 11.4 millions having decreased by 89.7 percent as compared to the corresponding period of the previous year. Deterioration of the indicators on "business services" was due to the decrease in the export of this item by 53.2 percent, at the same time, the import decreased by 23.3 percent. The main factor that affected the decrease in the export of business services was significant decrease in the consultation services provided by the residents of the Kyrgyz Republic. Decrease in the import of the given services is primarily due to the reduction of architectural, engineering and technical services received by the non-residents.

According to the results of the first half of 2015, the level of international services decreased by 16.5 percent, having set at the level of USD 795.0 millions.

Balance of international services was found negative and constituted USD 154.5 millions, which is by 20.7 percent higher of the deficit of the balance of services in the corresponding period of the last year. At the same time, the import of services decreased by 12.1 percent, at the same time, the export of services was also decreased by 22.3 percent.

In the reporting period, the **export of services** was found at the level of USD 320.3 millions, which corresponds to the 37.8 percent of the volume of export of goods.

In the reporting period, the main items of services traditionally were transport services, travels, business services, which in total made up more than 80.0 percent of the international services.

The balance of transport services in the first half of 2015 as before, was found negative in the amount of USD 153.6 millions, which is by 27.2 percent less than in January-June 2014. The increase in the volume of transport services provided by the non-residents by 5.8 percent was due to the growth of export of motor car transport services in 4.5 times. Decrease in the import

INCOME

Dynamics of the "incomes" item line was defined mainly by a growth in the volume of due and payable income on direct investments.

In January-June 2015, the balance of the item "income" was found negative in the amount of USD 174.7 millions, which is by 46.9 percent higher of the similar indicator of the first half of 2014.

This tendency is mainly based by the increase of the income of direct foreign investors from the investment activity in the Kyrgyz Republic by 54.8 percent due to the increase in the volumes of re-invested income of the entities from 77.8 to USD 132.7 millions (increase by 70.6 percent). The volume of distributed income of the companies-residents in the form of dividends in favor of foreign direct investors decreased by 63.1 percent and constituted USD 3.8 millions.

In the reporting period, the volumes of payment of the interests on the previously received loans increased by 26.5 percent due to the growth of payments on loans of the private sector and constituted USD 39.1 millions. At the same time, reduction of the volume of "other income" received by the residents of the country on other investments from 11.3 to USD 10.8 millions was observed. In general, this lead to the increase of the deficit of the item "incomes on other investments" by 44.2 percent (to USD 28.3 millions).

In the first half of 2015 the balance of item "remuneration" was also found negative in the amount of USD 9.8 millions (decrease by 11.4 percent), which was based by the decrease in the aggregate volume of income of non-residents from the work in the Kyrgyz Republic.

TRANSFERS

Incomes on the item "current transfers" decreased mainly due to the reduction of the inflow of private transfers.

Positive balance of **current transfers** according to the results of the first half of 2015 constituted USD 728.3 millions, which is by 24.9 percent less than the level of the compared period of the last year.

The defining impact on the current transfers was made by the **private transfers** (other sectors), net inflow of which decreased by 25.7 percent and constituted USD 698.8 millions. In the structure of private transfers, as before, the defining role have the money transfers of the workers, the specific weight of which in the general volume of incomes of private transfers constitute 97.4 percent. In the reporting period, decrease in the net volume of transfers received by 25.5 percent was due to the decrease in the inflow by 22.9 percent, whereas, the outflow of transfers decreased by 10.5 percent.

The main way of making labor migrants' money transfers to the country is via the money transfer systems¹⁰. In January-June 2015 the net volume of inflows received through the transfer systems constituted USD 619.0 millions¹¹, having decreased by 25.4 percent as compared to the similar indicator of the first half of 2014. At the same time, the geographic structure of money transfers experienced slight changes. According to the results of the first half of 2015, the major share of transfers was from the Russian Federation (92.3 percent). Specific weight of other countries is significantly less: 5.0 percent of transfers were from the Republic of Kazakhstan; 1.6 percent from United States.

In the structure of the transfers made from the Kyrgyz Republic, the prevailing specific weight fell within the Russian Federation (93.0 percent).

Money transfers are one of the sources of financing of the trade deficit. The balance of transfers covers net export of consumer goods, which in turn formed with a negative value of USD 513.8 millions.

In the first half of 2015 the balance of current transfers to **the sector of state governance** was positive in the amount of USD 29.5 millions, which is 1.6 percent more than in the same period of 2014.

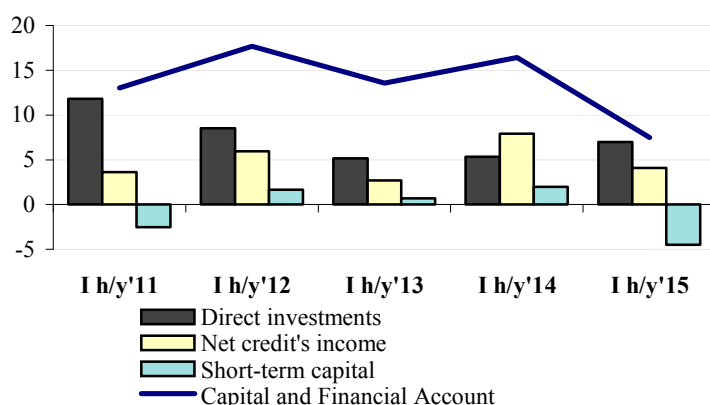
The amount of cash grants received by the public sector amounted to USD 31.1 millions. The volume of paid membership fees to international organizations in the reporting period decreased by 33.2 percent and amounted to USD 1.7 millions.

CAPITAL AND FINANCIAL TRANSACTIONS ACCOUNT

Due to the significant decrease in the inflow on the item "other investments", decrease in the positive balance of the capital and financial transactions account.

According to the results of the first half of 2015, the **capital and financial transactions account** was found with positive balance in the amount of USD 191.7 millions, which is by 61.6 percent less than the corresponding indicator of the similar period of 2014.

The balance of the **capital transactions account** was found negative in the amount of USD 26.5 millions, which is by 8.7 percent higher than the level achieved in the first half of 2014. Increase in the indicators of the reporting period was due to the growth of commodity grants by 41.1 percent.

Financial account according to the results of the first half of 2015 was found with positive balance in the amount of USD 165.1 millions, which is by 65.2 percent less than in was in January-June 2014. Decrease in the financial account was due to the outflow on the item "other investments".

In January-June 2015 the balance under "**other investments**" developed with the negative value in the amount of USD 134.1 millions. The main impact on the dynamics of this item was made by an increase in assets of residents of the country abroad, along with the reduction of liabilities to non-residents.

Assets of residents in the reporting period increased by USD 133.8 millions, which was mainly due to an increase in accounts receivable of residents to USD 86.4 millions and an increase in assets of commercial banks abroad by USD 41.3 millions. At the end of June 2015 more than 83.0 percent of the gross amount of receivables fell within the manufacturing industries, and institutions engaged in the field of electricity and gas, as well as professional, scientific and technical activities.

In the reporting period, assets of residents placed in the accounts in foreign banks, increased to USD 7.2 millions. More than 80.0 percent of the total volume of cash balances in the accounts of enterprises abroad was in manufacturing industries.

Reduction of liabilities of residents of the country was mainly due to the reduction in income from loans in the public and private sector. Gross inflow of loans of the public sector amounted to USD 56.7 millions, less than in January-June 2014 to 78.5 percent. Payments of the official sector of the principal amount of previously received loans, in the reporting half-year was formed in the amount of USD 35.7 millions. As a result, the net amount of loans received by the state amounted to USD 20.9 millions, having decreased compared with the figures of the first half of 2014 by 91.1 percent.

Gross inflow of loans to the private sector amounted to USD 98.3 millions, which is less than in January-June 2014 by 57.0 percent. Repayment of the private sector amounted to USD 170.0 millions, which is more than the figure of last year by 8.0 percent. As a result, the net inflow of loans to the private sector in the reporting period was found with a negative balance of USD 71.7 millions.

The volume of accounts payable of residents decreased by USD 23.4 millions in the reporting period. In general, the dominant share in the total amount payable is given to wholesale and retail trade, manufacturing, mining, information and communication, as well as electricity and gas, which together account for more than 87.0 percent of the total debt.

The balance under "**direct investments**" in the reporting period was positive and amounted to USD 283.3 millions¹², whereas in January-June 2014, it has developed with a negative value at the level of USD 17.4 millions. The main influence on this trend was made by the increased inflow of funds invested in equity capital in the amount of USD 349.3 millions. The net inflow of reinvested income in the reporting period increased by 70.6 percent and amounted to USD 132.7 millions.

In the reporting period, by type of economic activity, the highest net inflow of direct investments was observed in the manufacturing industries, provision (of supply) of electricity, gas, steam, as well as business entities engaged in construction and scientific and technological activities. In the geographical structure of direct investment the prevailing inflow is from Canada and the Russian Federation, while in terms of China outflow of direct investments was observed.

According to the results of 2015, **overall balance of payments** was found positive in the amount of USD 77.5 millions.

Balance of the "**errors and omissions**" item line was positive and amounted to USD 488.4 millions, which indicated incomplete statistical accounting of transactions related to capital inflow into the country or

exports of goods and services. Taking into account the National Bank's additional estimates, the balance of "errors and omissions" item line was positive and amounted to USD 133.8 millions.

The volume of gross international reserves amounted to USD 1 959.6 millions by the end of June, which covers 4.1 months of the future import of goods and services.

Chart I.1. Exchange Rate and the Real Effective Exchange Rate Index

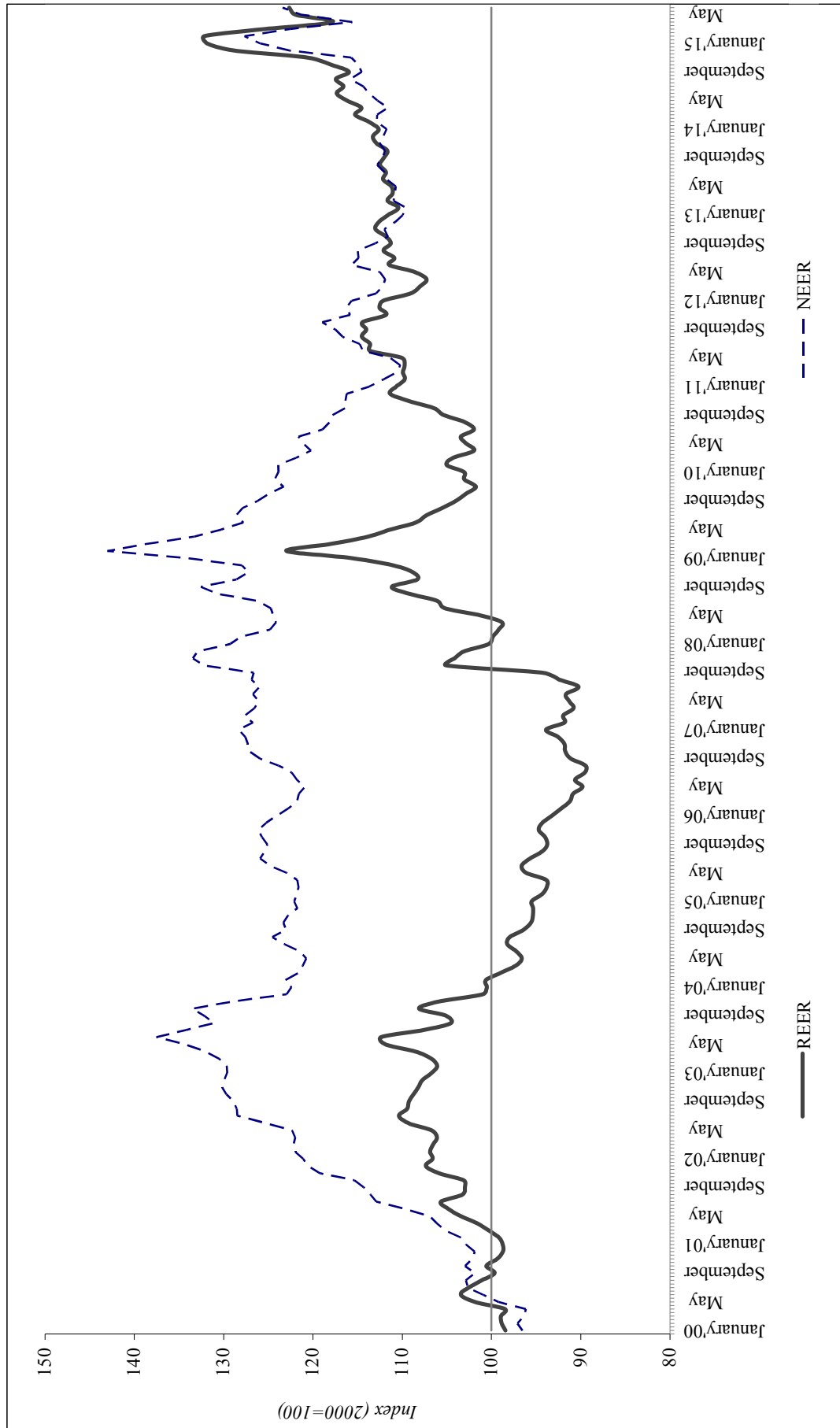
